These new fields will allow users to report on meal deduction information from the **Adjustments** page. These fields were added to the model for use with the Travel Allowance Service.

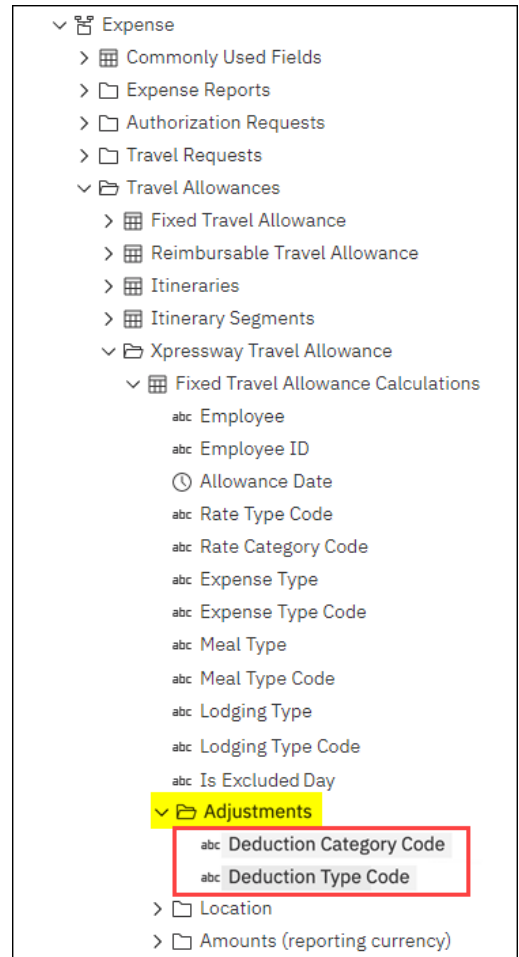

*Some pages in the SAP Concur solutions UI include links to product documentation or other content. In Q3 2023, SAP Concur plans to begin removing these links. The SAP Help Portal is the central source for all product documentation, release notes, and other content. SAP Concur clients can use the [SAP Concur](#) page on the SAP Help Portal to find the complete library of SAP Concur solutions documentation.*

As part of this initiative, the two product documentation links to the report catalog and data model documentation that are located within the Analysis and Intelligence UI will be removed.

We are currently targeting to remove the two documentation links from the Analysis and Intelligence UI in Q1 2024.

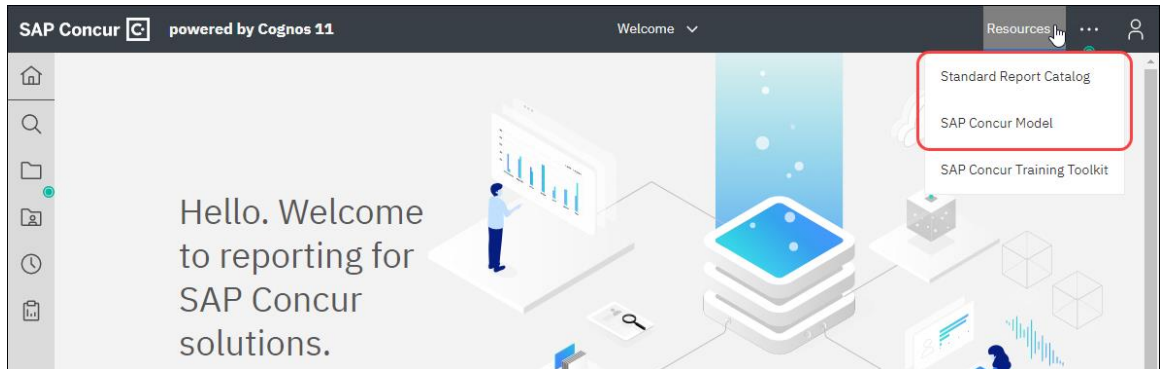
#### **BUSINESS PURPOSE / CLIENT BENEFIT**

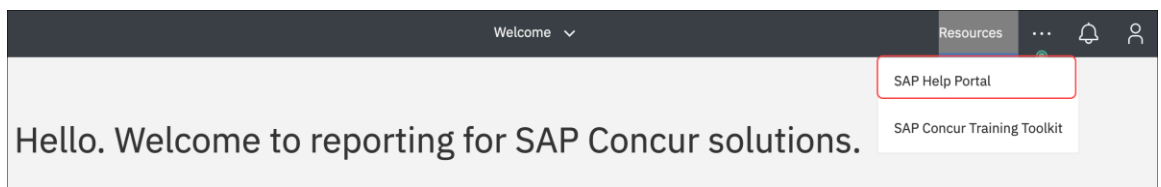

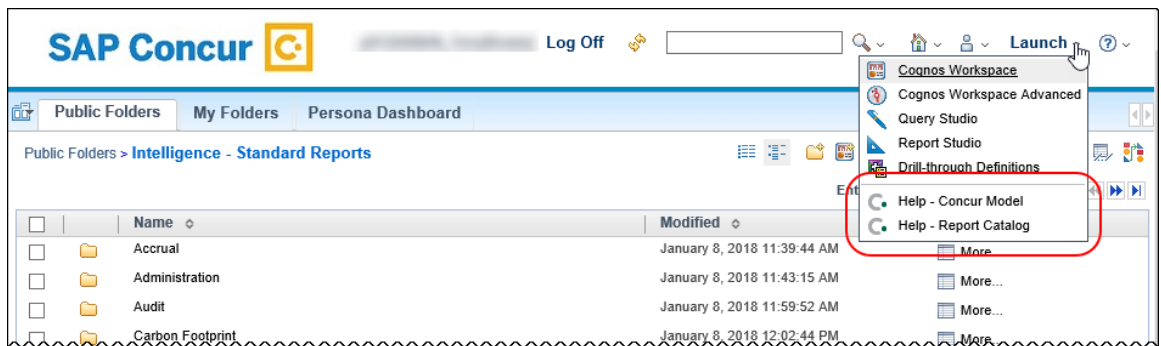
In Cognos 11, the **Standard Report Catalog** and **SAP Concur Model** links located on the **Resources** menu will be removed.



When the links are removed, a new link, **SAP Help Portal**, will be added to the **Resources** menu. Clicking the **SAP Help Portal** link will open the [SAP Concur](#) page on the SAP Help Portal.



In Cognos 10, the **Help - Concur Model** and **Help - Report Catalog** links on the **Launch** menu will be removed.

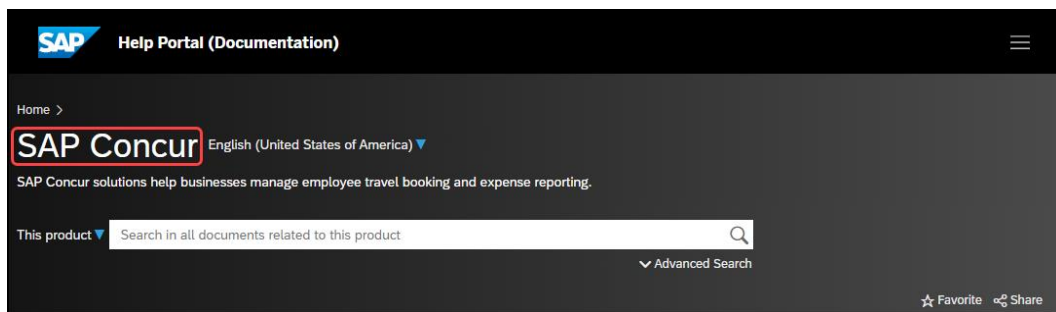

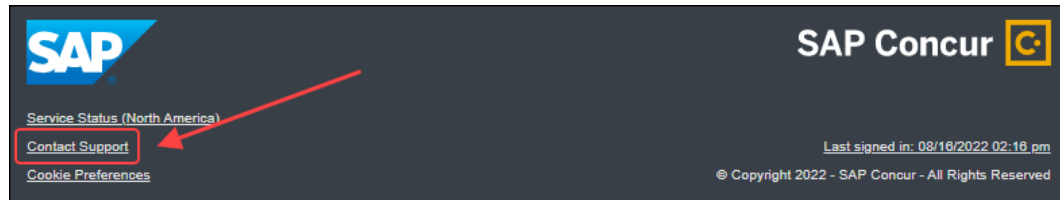
