Overview

Beginning in Q3 2023, SAP Concur plans to make a new **Sign-In Settings** page available to users with the Company Admin role. On the new **Sign-In Settings** page, a Company Admin will be able to define the login policy for SAP Concur solutions.

With the **Sign-In Settings** page, SAP Concur also plans to implement new login policy default settings.

The new **Sign-In Settings** page and policy defaults will be implemented in two phases.

Phase 1

Phase 1 begins on October 18, 2023. During this phase the new Sign-In Settings page becomes available and the new default settings are available.

CLIENT ADMINS

- The client's current password policy settings will be migrated to the new Sign-In Settings page. Any existing values that fall below or above the SAP Concur minimum or maximum values will be adjusted to fall within SAP Concur parameters.
- During phase 1, client admins will have access to the Sign-In Settings page, and they will be able to update the SAP Concur default settings to meet their company's requirements if needed. However, they will not be able to set values below the SAP Concur minimum requirements, or above the SAP maximum requirements.
 - For more information about the SAP Concur minimum and maximum requirement values, refer to the table in the SAP Concur Minimum, Maximum, and Default Values section of this release note.

ALL USERS

 During phase 1, existing users do not need to take any action unless they update their password after October 18, 2023. If an existing user changes their password during phase 1, the new password must meet the requirements set on the **Sign-In Settings** page.

 During phase 1, when a new user creates their password, their password must meet the requirements set on the Sign-In Settings page.

Phase 2

Phase 2 begins on November 15, 2023. During this phase, passwords for users who sign in to SAP Concur with a Concur username and password must meet the requirements set on the **Sign-In Settings** page.

<mark>All Users</mark>

- As of November 15, if an existing user signs in with a password that does not meet the requirements set in the **Sign-In Settings** page, the user will be prompted to update their password to meet the requirements.
- When a new user creates their password, their password must meet the requirements set on the Sign-In Settings page.

NOTE: SAP Concur also plans to implement mandatory two-factor authentication on the same schedule with the new **Sign-In Settings** page. For more information, refer to the *Mandatory Two-Factor Authentication (2FA) for SAP Concur Sign In* release note in this document.

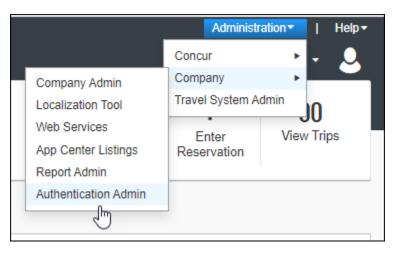

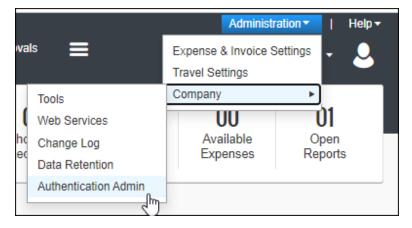

Overview

The Financial Integration Service (FIS) includes logic allowing processors to recall reports or invoices when certain conditions are met. In the October 2023 release, the FIS is updating that logic to fix a potential issue.

Currently the recall logic for a report or invoice extracted through Financial Integration Service (FIS) is allowed even if the posting document hasn't been created at the time of recall. This can happen when the processor approves a report or invoice and immediately recalls it, before FIS can create the posting document, or if there are many transactions on the report/invoice causing the posting document creation to take unusually long.

This results in a report/invoice in an editable status while there is a posting document in *Ready* status that may be imported to the financial system. This mismatch between the various systems will cause issues when the report/invoice is resubmitted and queued for financial integration after final approval.

Prior to this change, FIS allows the report/invoice recall if one of the following conditions is met:

- Associated posting document in *Ready* status
- Associated posting document in *Financial Posting Failed* status
- No associated posting document found (Error 404)

After this change, FIS allows recall if one of the following conditions is met:

• Associated posting document in Ready status

• Associated posting document in *Financial Posting Failed* status

In Q4, 2021, SAP Concur began redirecting clients to a new homepage. The appearance of the new homepage is identical to the previous SAP Concur homepage. The new homepage has enhanced functionality when services become temporarily unavailable.

The roll out of the new homepage is phased:

Phase 1: In October of 2021, SAP Concur began redirecting Concur Expense, Concur Invoice, and Concur Request clients in the US Datacenter to the new homepage.

Phase 2: In December 2021, SAP Concur began redirecting Concur Expense, Concur Invoice, and Concur Request clients in the EU Datacenter to the new homepage.

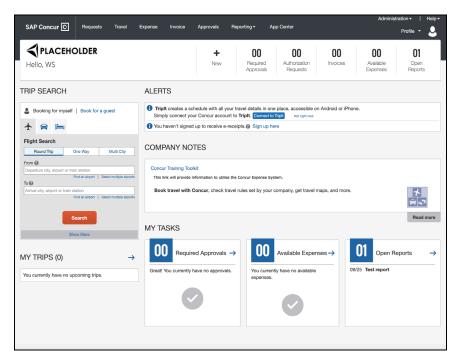

List items deleted by a client may now be viewed by the List administrator for the purpose of reviewing and optionally restoring them for use in Expense. This change is part of a phased effort over several releases to add features and safeguards when working with list items.

This ongoing phased update to managing list items helps prevent unintentional deletion and lets the client search for, review, and restore list items under certain conditions.

Administrator Experience

The List administrator will now see two new user interface additions, **Show Deleted** and **Reactivate**, with corresponding functionality when viewing list items.

Show Deleted is always displayed and uses the following values:

- No: Display active list items and sub-items
- Yes: Display all (active and deleted) list items and sub-list items

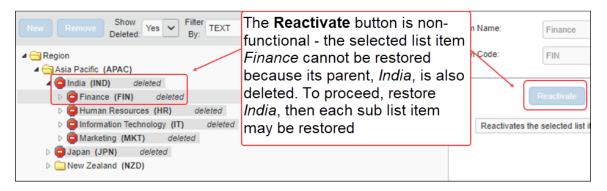
Reactivate is functional under the following conditions:

- Parent List Item: Is a deleted parent list item
- Child (Sub) List Item: Is a deleted child list item with an undeleted parent

The admin uses these to display previously deleted list items and then restore them to use under the conditions outlined above.

SCENARIO: REACTIVATE BUTTON UNAVAILABLE

Whenever the parent to a list item is in a deleted state, its child list item cannot be restored and the **Reactivate** button remains nonfunctional.



SCENARIO: REACTIVATE BUTTON AVAILABLE

Whenever the parent to a list item is in an active state, its child list item can be restored and the **Reactivate** button is functional.

To enhance the security of all SAP Concur users, SAP Concur plans to implement mandatory two-factor authentication (2FA) for users who sign in to SAP Concur solutions with a Concur username and password.

Mandatory 2FA will be implemented in two phases. The first phase is targeted for October 18, 2023. The second phase is targeted for November 15, 2023.

BUSINESS PURPOSE / CLIENT BENEFIT

2FA provides improved security for SAP Concur clients.

Implementation Phases for Mandatory 2FA

PHASE 1

Phase 1 of the mandatory 2FA implementation begins on October 18, 2023.

During this phase:

 All users can set up 2FA without adding or verifying an email address in the Email Address section of their Profile Settings > Personal Information page.

NOTE: Valid Email Address

A valid email address is an email address that can send and receive email messages.

• Although a valid email address is not required during this phase, SAP Concur recommends that users add a valid email address before phase 2 begins on November 15, 2023.

NOTE: SAP Concur also plans to implement a new sign-in policy settings page and default sign-in policy settings on the same schedule with 2FA. For more information, refer to the *New Sign-In Settings Page* release note in this document.

• Beginning on October 18, if it is not already setup, after a user enters their SAP Concur sign in credentials (username and password) on the Concur sign in page, they will be prompted to setup 2FA.

PHASE 2

Phase 2 of the mandatory 2FA implementation begins on November 15, 2023.

During this phase:

 To ensure they can receive a link via email to begin the setup of 2FA, all users must have a valid email address added to the Email Address section of their Profile Settings > Personal Information page in Concur.

NOTE: Company Admins will be able to disable the email address requirement through the new **Sign-In Settings** page.

For more information about the **Sign-In Settings** page, refer to the *New Sign-In Settings Page* release note in this document.

- If the user does not have a valid email address added to their profile, they must contact their Company Admin or Concur Customer Support to setup 2FA.
- The user's email address must be a valid one, but it does not have to be verified.

NOTE: A verified email address is an email address that has been successfully verified through the **Email Address** section of a user's **Profile Settings > Personal Information** page in Concur.

Users are **not** required to verify their email address.

Company Admins will have the option to opt out of phase 2 and enforce only phase 1. The option to disable phase 2 will be available through the new Sign-In Settings page. The ability to opt out of phase 2 on the new Sign-In Settings page will be available one week prior to launch of phase 2.

Implementation of the SAP Fiori with Horizon visual design theme impacts the look and feel of SAP Concur solutions by updating fonts, font sizes, icons, colors, and shapes. In addition, in both the SAP Concur mobile and web UI, navigation from the home page is slightly modified.

Introduction of the new design themes will be phased beginning on May 20, 2023. SAP Concur plans to fully implement the new theme, decommissioning the current, legacy theme, in 2024.

BUSINESS PURPOSE / CLIENT BENEFIT

These changes improve the overall user experience, better support accessibility features, and help to provide a consistent user experience across all SAP products.

SAP Concur has implemented SAP Fiori with Horizon in the Mobile app.

WEB UI

SAP Concur began implementing SAP Fiori with Horizon themes in phases beginning in May 2023:

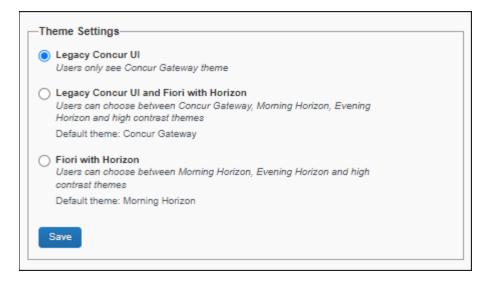
Phase 1 – May 20, 2023, and June 22, 2023: On May 20, 2023, SAP Concur implemented **Theme Settings** for SAP Concur Professional edition clients and for most Standard edition clients. On June 22, 2023, **Theme Settings** were enabled for the remaining Standard edition clients.

Admins with the required permissions can access **Theme Settings** from the following locations:

- **Standard Edition:** Theme settings are accessed from the **Administration > Tools** page.
- Professional Edition: Theme settings are available on the Administration
 > Company > Company Admin > Company Settings page.

In the theme setting section, admins can choose between the following options:

- **Legacy Concur UI:** End users only see the legacy Concur Gateway theme.
- Legacy Concur UI and Fiori Horizon: End users see the legacy Concur Gateway theme by default. On the **Profile Settings > System Settings** page, they can choose between the Concur Gateway theme, Morning Horizon, Evening Horizon, and high contrast themes.
- Fiori Horizon: End users see Morning Horizon by default. On the Profile Settings > System Settings page they can choose between the Morning Horizon, Evening Horizon, and high contrast themes.



If you select **Legacy Concur UI** and then click **Save**, the following message is presented:

"Successfully updated theme settings!

Users can set themes on the Profile System Settings page. The page will be reloaded to show changes."

If you select **Legacy Concur UI and Fiori with Horizon** and then click **Save**, the following message is presented:

"This change to theme settings is permanent and cannot be undone. The Fiori with Horizon themes will be options for users to use and cannot be removed. Okay to proceed?"

After you click **OK**, the following message is presented and the **Legacy Concur UI** option is no longer available in **Theme Settings**:

Users can set themes on the Profile System Settings page. The page will be reloaded to show changes."

If you select the **Fiori with Horizon** option, after you click **OK**, all options in **Theme Settings** are removed and the follow message is presented:

"Users can choose between Morning Horizon, Evening Horizon and high contrast themes Default theme: Morning Horizon

This company is already using the latest theme settings"

NOTE: If you select **Fiori with Horizon** in **Theme Settings**, you will not have the option to revert to options that include the legacy Concur Gateway theme until the option is made available in October 2023.

Phase 2 – Beginning October 2, 2023: On October 2, 2023, SAP Concur plans to start the process of setting Morning Horizon as the default SAP Concur UI theme for all clients. The process of updating all existing SAP Concur clients to the new default setting will take some time. New clients will automatically default to the Morning Horizon theme.

When Morning Horizon becomes the default UI theme in October, existing SAP Concur client admins will have access to **Theme Settings** and will be able to revert to the legacy Concur Gateway theme.

NOTE: When Morning Horizon becomes the default theme, Admins for preexisting Concur entities will be able choose either the legacy Concur Gateway theme or SAP Horizon for Fiori themes. A hybrid option that enables both sets of themes will not be available.

Phase 3 – April 2024: SAP Concur plans to decommission the legacy Concur Gateway theme. When it is decommissioned, Morning Horizon will become the default theme and end users will be able to choose between Morning Horizon, Evening Horizon, and high contrast themes.

NOTE: Clients with SAP Fiori Quartz themes: On October 2, 2023, SAP Concur will decommission the SAP Fiori 3 Quartz themes and clients with SAP Fiori 3 Quartz themes will automatically default to the SAP Fiori with Horizon visual themes.

Implementation Schedule for Clients with Concur Budget

Currently, some screens in Budget are not fully compatible with Horizon for Fiori themes.

NOTE: This does not impact SAP Concur mobile app. Budget clients already have access to the new theme on the mobile app.

To address this issue, clients with Budget will be migrated to the new themes on the following schedule:

Phase 1 – October 2023: Beginning on October 2, 2023, Budget clients will be able to opt in to the Horizon for Fiori themes. The opt-in phase will last approximately 90 days.

Phase 2 – January 2024: Beginning in January 2024, SAP Concur plans to implement Morning Horizon as the default SAP Concur UI theme for clients with Budget. The process of updating all existing SAP Concur clients to the new default setting might take some time.

NOTE: New clients with Budge will automatically default to the Morning Horizon theme.

When Morning Horizon becomes the default UI theme in October, existing SAP Concur client admins will have access to **Theme Settings** and will be able to revert to the legacy Concur Gateway theme.

NOTE: When Morning Horizon becomes the default theme, Admins for preexisting Concur entities will be able choose either the legacy Concur Gateway theme or SAP Horizon for Fiori themes. A hybrid option that enables both sets of themes will not be available.

Phase 3 – April 2024: SAP Concur plans to decommission the legacy Concur Gateway theme. When it is decommissioned, Morning Horizon will become the default theme and end users will be able to choose between Morning Horizon, Evening Horizon, and high contrast themes.

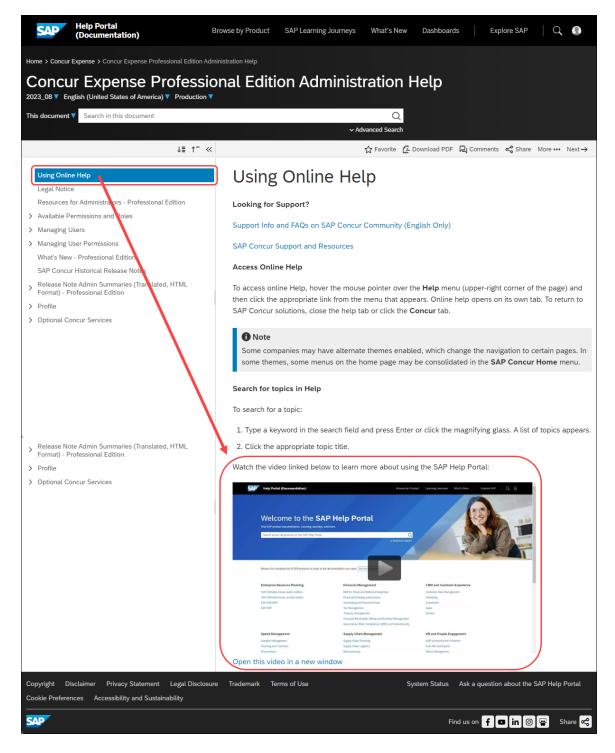

Overview.

Sign-in With Concur (SiwC) functionality enables an app to access a user's SAP Concur account through an authorized endpoint. This functionality is typically used by partner applications.

In early November 2023, SAP Concur plans to implement the following improvements to SiwC functionality:

- Make the experience consistent with the SAP Concur mobile and web sign-in experiences.
- Allow users to sign-in using SSO (in accordance with company policies).
- Add support for localization of the SiwC page into all SAP Concur-supported languages.

NOTE: These changes are backwards compatible. Applications that currently use SiwC functionality should not require any updates to accommodate these changes.

BUSINESS PURPOSE / CLIENT BENEFIT

These enhancements improve the consistency of the user sign-in experience, enable users to sign-in through SSO (if their company policies allow it), and enable the localization of the sign-in page.

End-User Experience

End users who are prompted to sign in to their SAP Concur account through a partner app or other method that uses SiwC functionality will see an updated sign in page.

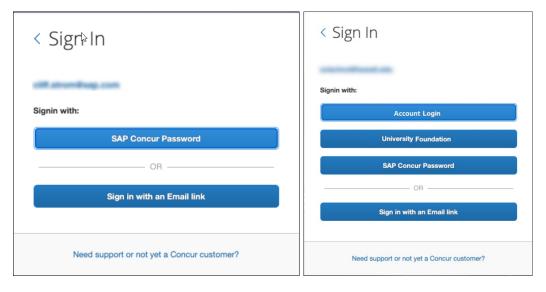

The sign in page includes an option to review a list of the information the application is authorized to access if the user signs in to their SAP Concur solutions through SiwC. The authorization list varies depending on the application. For example, an application might be authorized to read a user's profile information, read company profile information, obtain traveler preferences, or obtain an OPENID token. After a user enters their username, verified email address, or company SSO Code, the available sign in options are presented. The available options depend on their company's configuration.

The user can also click **Sign in with an Email link** to receive an email with a sign-in link. After clicking **Sign in with an Email link**, an email is sent to the email address provided on the first sign-in page and the following message is presented:
