# Company Administration

---

## Section 1: About this Guide

The information in this guide applies to Company Administration feature in Travel as well as Travel & Expense. For consistency, the Travel service will be referred to as "Travel" in this guide.

*This guide contains information that describes the new Concur Travel experience for Car, Hotel, and Air. This information will be displayed in notes or indicated with "new experience" as these features are released.*

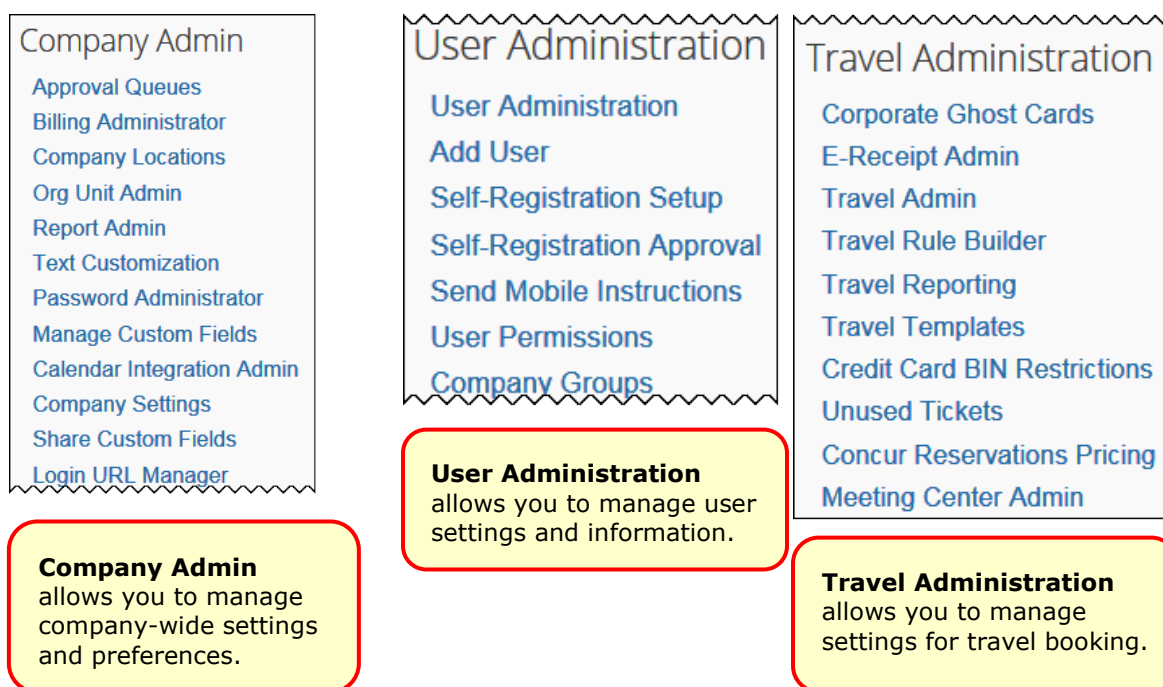
**NOTE:** Multiple SAP Concur product versions and UI themes are available, so this content might contain images or procedures that do not precisely match your implementation. For example, when SAP Fiori UI themes are implemented, home page navigation is consolidated under the SAP Concur Home menu.

---

## Section 2: Introduction to Company Admin

Use the **Company Administration** section in Travel to manage company options, user data, and travel booking settings. You can access Company Administration by clicking the **Administration** link at the top of any Travel page.

On the **Company Administration** page, you can access different sections by using the left-side menu. Company Administration is organized in three sections.



Log in to Travel - Access Company Admin

► **To log in to Travel and access Company Admin:**

1. Access the Travel login page.
2. Type your user name in the **User Name** field.
3. Type your password in the **Password** field.

---



**NOTE:** Remember the password is case sensitive.

---

4. Click **Login**.
5. On any Travel page, click **Administration** in the menu.

## Section 3: Company Administration Section

The **Company Administration** section allows management of company-wide settings and preferences including:

Calendar Integration Admin	Automatically add trip data into user calendars

Share Custom Fields	 For complete details, refer to the <i>Hotel Service Content Suppliers Travel Service Guide</i> .
Login URL Manager	Manage general company settings
New Concur Travel Experience	Options to manage preferences for the new Concur Travel experience for Air, Hotel, and/or Rental Car bookings

## Approval Queues

### Overview

Use the **Approval Queues** option to reassign bookings awaiting approval with one manager, to a different manager. This is helpful if a manager is absent and, therefore, unable to approve trips.

---

**NOTE:** This feature should not be used for clients using Concur Request for their trip approvals.

---

### Reassign a Trip Awaiting Approval to a Different Manager

► **To reassign a trip waiting approval to a different manager:**

1. In the **Company Admin** section of the left menu, click **Approval Queues**. This page appears.

This screen allows you to reassign requests from one person's approval queue into another person's approval queue. To do this:

1. Select a manager (left).
2. Check the items you wish to reassign (center).
3. Select the user who will take over responsibility for approving these items (right).
4. Click **Reassign**.

2. Type the manager's name whose approvals you wish to reassign.
3. Click **Select**. A list of the approvals appears.

This screen allows you to reassign requests from one person's approval queue into another person's approval queue. To do this:

1. Select a manager (left).
2. Check the items you wish to reassign (center).
3. Select the user who will take over responsibility for approving these items (right).
4. Click **Reassign**.

4. In the **All Queued Requests** area, click the request(s) you want to reassign to a different manager or select (enable) the **Check all** box.
5. Type the name of the approver who will receive the items.
6. Click **Reassign**. The trip is then reassigned to the new manager, who can approve or reject it.

## Billing Administrator

### Overview

Use the **Billing Administrator** option to see your recent bills from Concur. This area provides the actual dollar amount and the number of transactions based on transactions processed in Travel.

You might receive your bills from your travel agency, not from Concur. In that case, please contact your travel agency for more information on billing.

---

**NOTE:** The **Billing Administrator** option is intended for Direct Clients and TMCs only. **Reseller Clients should not use this feature.**

---

### View Invoices

#### ► To view invoices:

1. In the **Company Admin** section of the left menu, click **Billing Administrator**. This page appears.

2. In the **View Invoice for date** dropdown menu, select a month to view invoices from prior months.
3. Then, either:
  - ◆ Click **View Invoice** to display an invoice.

## Company Locations

### Overview

Use the **Company Locations** option to set up company locations for your organization. There are several uses for company locations:

- You can assign users to company locations in order to automatically add a work address to their user record. Users have the ability to update their own home or work addresses in their profile.
- Users can use company locations to search for hotels in Travel. When users search for a hotel using company location, they can choose from this list of locations.
- If a car rental vendor provides car delivery and collection, the company location is the drop-off and pick-up point.

---

**NOTE:** This feature is available for all GDSs except Worldspan.

---

### Geocode

*Geocoding* is the process of assigning latitude and longitude to a point, based on street addresses, city, state, and zip code. In Travel, the Geocoding option adds the latitude and longitude to a company location. This enables users to search for hotels by company location.

#### ▶▶ Best Practice tips:

- It is not required to add zip code when adding company locations, however results will be more accurate if zip code is included.
- For best results, do not include suite or floor numbers with the street address. You can enter this information after you geocode but before you save to include it as part of the address.
- When entering company locations, enter the addresses consistently. The company location list is in alpha order by country code. Then, they are listed by city, state, and location name. If you enter the state for one location but not for another, they will appear under separate headings in the locations list.
- For addresses containing the number (#) sign, change this to the word *Number* or abbreviation *No.* The map provider may not recognize the # sign.

### **Edit a Company Location**

#### **► To edit a location:**

1. In the **Company Admin** section of the left menu, click **Company Locations**.
2. Click the **Edit** link next to a location.
3. Edit the address for the location. (All fields are described in the section above about adding a location.)
4. Click **Save**.

### **Delete a Company Location**

#### **► To delete a location:**

1. In the **Company Admin** section of the left menu, click **Company Locations**.
2. Click the **Edit** link next to a location.
3. Click **Delete**.

## Org Unit Admin

### Overview

Use the **Org Unit Admin** option to create departments or organization units for your company. Creating organization units makes it easier to manage users. For example, if you create and assign organization units, you can later sort or filter users by unit to update information and report data.

---

**⚠ IMPORTANT:** Some travel agencies use the Org Units to manage company-level profile information in Travel. Consult with your travel agency before modifying Org Units to prevent disabling the service for all your travelers.

---

### Create an Organization Unit

► **To create an organization unit:**

1. In the **Company Admin** section of the left menu, click **Org Unit Admin**. This page appears.

## **Edit or Delete an Organization Unit**

1. In the **Company Admin** section of the left menu, click **Org Unit Admin**.
2. In the list, locate the organization unit to be renamed or deleted.
3. In the **Action** column:
  - ◆ Click **Edit** to enter a new name.  
– or –
  - ◆ Click **Delete**.

## **Assign an Organization Unit to a User**

### ▶ **To assign an organization unit:**

1. In the **User Administration** section of the left menu, click **User Administration**.
2. Search for the user to assign to an organization unit.
3. Click the name of the user (link) to open their record.
4. In the **Org Unit/Division** dropdown menu, click the organization unit for the user.
5. Click **Save**.

## **Text Customization**

### **Overview**

Use the **Text Customization** option to customize the text that appears at the top of the user's profile page. For example, you can include messages here to the user about filling in or modifying their profile, including warnings about required fields.

### **Considerations for Customizing Text**

Using the **Text Customization** option to enter a customized message for a particular travel configuration or company-wide. If you choose company-wide, the customized text will appear for any configuration that does not already have customized text applied.

On the **Text Customization** page:

- If you select (enable) the **Use Default** check box, Travel will show the following default message in the language you choose.

Disabled fields (gray) cannot be changed. If there are errors in these fields, contact your company's travel administrator.


Fields marked **[Required]** and **[Required\*\*]** (validated and required) must be completed to save your profile.

- If you clear (disable) the **Use Default** check box, you can choose a language and enter your own message.

## Customize Profile Text

### ► To add custom text:

1. In the **Company Admin** section of the left menu, click **Text Customization**. This page appears.

**NOTE:** The **Security Keys** link is available only if your company uses SSO.

1. In the **Company Admin** section of the left menu, click **Security Keys**. This page appears.

## Manage Custom Fields

**NOTE:** Best practice is to **not** allow personal, sensitive, or uniquely identifying information in custom fields.

### Overview

Use the **Manage Custom Fields** option to customize the following types of fields.

**⚠ IMPORTANT:** Because certain travel agencies use custom fields to pass information into the booking system, you should not modify these fields unless you first verify with your travel agency or Concur Client Support. If you do not verify first, you risk causing serious issues with profiles and itineraries in the agency booking system.

Field type	Description/Action
User fields	<p>User fields appear on the <b>User Profile</b> page.</p> <p>Specify the field name and the type of information that can be entered in the field.</p>
Trip fields	<p>Trip fields appear during the process of booking a trip.</p> <p>Specify the field name and the type of information that can be entered in the field. You can also choose whether trip fields will appear to the user at the beginning or end of the booking process and whether the fields are required.</p> <p><b>Using If / Then logic:</b> When defining or editing a custom trip field, you can also select another custom trip field/value combination to control when to ask the secondary question. This means Concur can ask a user a question, such as "What is the purpose of your trip?" and the answer to that question can drive a secondary question. For example, if the answer to the question is "Meeting travel" then you can ask the user "Which meeting are you attending?"</p>

## Considerations for Creating Custom Fields

---

**NOTE:** Best practice is to **not** allow personal, sensitive, or uniquely identifying information in custom fields.

---

### TREATMENT OF EXISTING DATA

When you create new custom fields, you must consider how existing data might be affected. Travel will treat existing data as follows:



## USING IF / THEN LOGIC

When defining or editing a custom trip field, you can select another custom trip field/value combination to control when to ask a secondary question. For example, SAP Concur can ask the user a question, such as "What is the purpose of your trip?" If the answer to the question is "Meeting" then Concur will ask the user "What is the name of the meeting?"

You can also use this area to display custom trip fields (questions asked during the booking process) based on the value of a custom profile fields. For example, you could drive a question during the booking process for only the travelers with a business unit of Marketing. This avoids having to create separate travel classes or configurations to have different questions asked of different travelers.

Note the following:

- Yes/No and Long Text fields cannot currently be used to control the display of other fields.
- **Both** custom trip fields must exist before the if/then logic can be set up.
- For display of a trip custom field based on a value in a profile custom field, that profile custom field in the user profile of the traveler **MUST** contain a value. Display of a trip custom field only if a profile custom field does **NOT** contain any value is currently not a supported use case.
- Display of a trip custom field based on a value in a profile custom field is currently not supported with the **has a value** or **has no value** options. Instead, use options **is** or **is not**.

### ► To use if / then logic with trip fields:

1. Follow normal steps, such as defining the field name and display names (if needed), identifying which configurations or travel classes this field will apply to, and defining whether it will be a text box or dropdown.





Concur has a global list of allowed URLs to be used for logout redirection. If a client wants to control the URL that should be called after logout, the client can set up one or more URLs to be allowed in a list of the company-specific logout URL. Once set up, only the URLs in the company-specific list are allowed. If the company-specific list is empty, the global Concur list of the allowed URLs will be used.





The **Manage New Concur Travel Experience Preferences** screen displays. This will allow the Company Administrator to select or unselect the **Air Bookings**, **Hotel Bookings**, and **Rental Car Bookings** options to enable or disable it for the new Concur Travel experience. Click **Save** once the options are selected.

**NOTE:** Any changes made at the travel configuration level will override the preference set at the company level.

Travel configurations with overrides display first in the **Configuration Level Override(s)** section, followed by **Company Level**.

► **To Remove an Override on a Travel Configuration:**

### User Administration and Add User – Travel Only

#### Overview

Use the **User Administration** and **Add User** options to add users, change passwords, and manage other information for Travel users.

This section of this guide describes the fields that are available for each user. You can create custom fields to store data, as needed, using the **Manage Custom Fields** section in this guide.

**NOTE:** Many companies limit the records that a user can edit. If you are using Expense, please be aware of the fields that you are allowed to edit. If you are unsure, please check with your Travel or Expense implementation consultant or Concur Client Support.

## Search for Users

It is useful to be able to search for specific users when you need to review user information or make updates to user records. 2. Select (enable) the **Show Filters** check box to view the search fields.
3. Enter the search criteria.
4. Click **Search**.
5. In the results list, click the name of the user (link) that you want to review.
6. On the **User Detail** page, review the user's information.
7. Make any required updates.
8. Click **Save**.

## Add Users

### ► To add a user:

1. In the **User Administration** section of the left menu, click **Add User**.

**NOTE:** You can also add new users from the **User Administration** page by clicking **Add New User**. You can also import users from other sources. For more information on importing users, contact your administrator.

Title, First Name*, Middle Name, Last Name*, Suffix	<p>Enter or select (enable) as appropriate.</p> <p><b>IMPORTANT!</b> The user's name should always be the name that appears on their identification for travel purposes.</p>
Account Activation Date	<p>Enter (or select using the calendar) the date the user record was created, either in User Administration or through a synchronization with the Global Distribution System (GDS).</p>
Account Termination Date	<p>Enter (or select using the calendar) the date the user will stop using Travel.</p> <p>If someone is leaving the company or will no longer be traveling, set this date to the last date the person will use Travel. You can set this to a date in the past to deactivate someone immediately.</p>
Employee ID	<p>Enter the user's employee ID number.</p>
Email Address	<p>Enter the user's email address.</p> <p>Keep in mind that all notifications sent through Travel will be sent to this email address.</p>





- The default email information appears and the admin can edit the **From**, **Subject**, and **Message Text** portion of the email as desired.
- Concur will default the "From" email address to the email1 of the administrator who is creating the new user.
- The **Message Text** section supports up to 1,000 characters, which includes spaces.
- There is no mechanism to permanently edit the information that appears by default. If the admin wants to make changes, they must change it for each new user.

## Unified User Admin – Travel & Expense

### Overview

The **User Administration** page is used by Travel or Expense Administrators to add new users, assign user roles, and modify user profiles. The User Administration page contains the fields used on the Employee Profile form in Expense and/or the Travel Preferences fields from Travel. The fields displayed will vary depending on the user role selected for the new user.

## Send Mobile Instructions

Use the **Send Mobile Instructions** option to select one or more Concur users and email the Concur Mobile download and login instructions. This email is the same as the one that the user generates on the Mobile Registration page.

This feature is available to admins with any of these permissions:

- User Administration
- Employee Maintenance
- User Admin (Read Only)

To send the emails:

1. In the **User Administration** section of the left menu, click **Send Mobile Instructions**.
2. To locate a particular user, type part of the user's name or email address in the **Find in name and/or email** field and click **Search**.

3. Select (enable) the **Exclude mobile users** check box to **not** show users who have already logged in to Concur for Mobile or have registered a PIN.
4. Select the desired users. The selected users appear at the bottom of the page.

### Overview



Use the **User Permissions** option to assign permissions to individual users, groups of users, users in a rule class, or to everyone in your company. The available permissions are determined by your travel configuration. You can:



- Grant access to particular features in Travel, such as Travel Administration and Reports.
- Verify the permissions available to a person or a group.




The following table describes the available permissions in Travel.

App Center Listing Administrator	The user assigned this role can submit App Center listings. This role is only assigned by SAP Concur to certain App Center partners.
Administer Approval Queue	Allows users to reassign approval requests You can assign this permission by itself.
Agency Billing Administrator	Allows users to access agency billing administration
Approve then Book	Allows users to enable travel booking from an approved request  For more information, refer the <a href="#">Travel Release Notes, February 2020</a>
Authorized Support Contact (ASC)	Allows user to request configuration changes and enable/disable features under My Profile in the SAP Concur support portal.  For more information, refer to the <a href="#">Travel Release Notes, January 2019</a>
Billing Administrator	Allows users to view bills from SAP Concur You must assign this permission with one other administration permission.
Company Administration	<p>Automatically assigns:</p> <ul style="list-style-type: none"> <li>• Administer Approval Queue</li> <li>• Billing Administrator</li> <li>• Company Locations Administration</li> <li>• Corporate Ghost Cards</li> <li>• E-receipt Admin</li> <li>• Group and Shared Resources Administration</li> <li>• Managed Meeting Center Admin (ONLY if the Third Party Meeting Module has been enabled)</li> <li>• Organization Unit Administration</li> <li>• Permission Administrator</li> <li>• Report Admin</li> <li>• Travel Policy Administrator</li> <li>• User Administration</li> <li>• Web Services Admin</li> </ul> <p><b>NOTE:</b> When you also select the User Administration permission, the <b>User Permissions</b> link becomes available in Company Administration.</p>

Company Discount Administrator	<p>Allows users to add site-level discounts</p> <p>This feature is available to the user when you select this permission and the <b>Allow Discount Editing</b> option has been enabled in the Company Travel Configuration for the customer site.</p> <p> Refer to the <i>Travel System Admin User Guide</i>.</p> <p>This permission must be combined with the Travel Policy Administrator permission.</p>
Company Link Administrator	<p>Allows customers/TMCs the ability to include/exclude links, redirect links, and add new links to the Travel Tools page</p> <p> Refer to the <i>Company Link Administrator Travel Service Guide</i>.</p>
Company Locations and Maps	<p>Allows users to enter locations for travelers to use when searching for hotels or off-airport car locations</p>
Concur Meeting Accountant	<p>Allows users to add credit cards to a meeting and download payment files</p> <p><b>NOTE:</b> This permission will appear only if you have enabled Meeting via the new site setup work order.</p>
Concur Meeting Admin	<p>Allows users to access Meeting administration; allows Meeting administration <b>with</b> the Concur registration module</p> <p><b>NOTE:</b> This permission will appear only if you have enabled Meeting via the new site setup work order.</p>
Concur Meeting Planner	<p>Allows users to access <b>all</b> Meeting pages <b>except</b>:</p> <ul style="list-style-type: none"> <li>• Travel &gt; Agency Settings</li> <li>• Travel &gt; Form of Payment</li> <li>• Tracking &gt; Payment (the <b>Edit</b> link is hidden from within the Payment page)</li> </ul>
Corporate Ghost Card Administrator	<p>Allows user access to the <b>Corporate Ghost Cards</b> link on the <b>Company Admin</b> page</p> <p><b>NOTE:</b> The <b>Company Groups</b> link and the links in the <b>Group Administration</b> section are always present for anyone with administrative privileges, but users can only edit (not add) groups they own if they do not also have the Group and Shared Resources Administration permission.</p>
Custom Field Administrator	<p>Allows user access to the <b>Manage Custom Fields</b> link on the <b>Company Admin</b> page</p> <p><b>NOTE:</b> The <b>Company Groups</b> link and the links in the <b>Group Administration</b> section are always present for anyone with administrative privileges, but users can only edit (not add) groups they own if they do not also have the Group and Shared Resources Administration permission.</p>

Permission	Description/Action
Data Retention Administrator	Allows users access the <b>Data Retention</b> link on the <b>Company Admin</b> page and the <b>Hold User</b> and <b>Purge User</b> buttons in <b>User Administration</b> .
Employee Maintenance	Allows users to update, modify, and delete – but not create – a new user in User Admin  This role is ideal for clients seeking tighter fraud control.
Group and Shared Resources Administration	Allows users to view and modify groups  You can assign this permission by itself.  <b>NOTE:</b> If a user owns a group or is in a group that owns a group, the user will not be able to modify that group without this permission. Ownership of a group provides no additional access.
Guest Booking	Allows users to create reservations for non-profiled travelers   Refer to the <i>Sponsored Guest User Travel Service Guide</i> and the <i>Non-Profiled Travel Travel Service Guide</i> .
Import Data Administrator	Allows the user to import data from a customer site, instead of logging into the agency site and selecting <b>Administration &gt; Travel &gt; Travel System Admin &gt; Import Data</b>
Localization Admin / Localization User	Localization Admin is assigned only <b>to</b> SAP Concur employees.  Localization User is assigned only <b>by</b> a Localization Admin.
Manifest Administrator	Allows users to perform a multi-user clone  This role allows companies to determine who should manage travel on behalf of a large group.
Meeting Center Developer Third Party	Allows users to test screens and documentation for a third-party meeting product with XML integration  <b>NOTE:</b> This permission appears only if you have enabled Concur Meeting via the new site setup work order.
Online Order Form Access	Used by TMCs to allow its agents to access to the online order form  <b>NOTE:</b> This permission is visible only when the Concur Travel Reseller module is given to the TMC by Concur.   Refer to the <i>Online Order Form Travel Service Guide</i> .
Organization Unit Administration	Allows users to create and edit organizational units  You can assign this permission by itself.

Password Manager	<p>Allows users to update passwords for Travel users</p> <p>User will have read-only access to the following fields on the <b>User Details</b> page in User Administration: Title, First Name, Middle Name, Preferred Name, Last Name, Suffix, and Email.</p> <p><b>Preventing Access:</b> A module property is available to restrict this role from changing passwords - contact SAP Concur directly to have the <i>Password Access Restriction</i> feature activated.</p> <p><b>NOTE:</b> The users with Travel and either Expense or Invoice have one password for all applications. When any of the Password Manager roles changes a password, it changes for all applications.</p>
Permission Administrator	<p>Allows the user to assign user permissions</p> <p><b>NOTE:</b> This role is automatically assigned when the Role Administrator role is assigned via Expense, Invoice, and Request.</p>
Profile sync administrator	<p>Allows users to update and retrieve passwords from the <b>Profile Sync Configuration</b> page</p>
Profile User	<p>Allows users to update their profile only and not have access to the Travel booking wizard.</p> <p><b>NOTE:</b> When a site is created, the 'ALL' group is automatically added to the Travel Wizard User permission. You must manually remove the 'ALL' group from this permission if you do not want travelers to have access to update both their profile and make a reservation.</p> <p>Make sure the Project team has access to the booking wizard for testing purposes by creating another Group for that team, and granting the appropriate permissions.</p>
Report Admin	<p>Allows users to determine who has access to reports</p> <p> Refer to the <i>Travel Reporting User Guide</i>.</p> <p>You can assign this permission by itself.</p>
Report User	<p>Allows users to view reports</p> <p>You must assign this permission in order for users to view company reports; however, you must also assign individual reports in the Report Admin.</p> <p> Refer to the <i>Travel Reporting User Guide</i>.</p> <p>You can assign this permission by itself.</p>
Self-assigning Assistant	<p>Allows users to assign themselves as an assistant</p> <p>If you assign this permission to a user or group, those users can select a traveler to assist.</p>
Self-Registration Approver	<p>Allows users to approve the self-registrations within their own company</p> <p> Refer to the <i>Self-Registration Travel Service Guide</i>.</p>

Sponsor	<p>Allows users to be searched for and assigned as the sponsor for the guest user</p> <p> Refer to the <i>Sponsored Guest User Travel Service Guide</i>.</p>
Travel Agent	<p>Allows users to access Concur Expert Agent (XA), if you have also assigned the Company Administration permission</p> <p>With this permission:</p> <ul style="list-style-type: none"> <li>The <b>Travel System Admin</b> link may be displayed but will only provide data based on the backend setup.</li> <li>The <b>Import Data</b> link will appear within Company Administration.</li> </ul>
Travel Meeting Center Admin Third Party	<p>Allows users to use a third-party meeting product with XML integration administrator screens; allows Meeting administration <b>without</b> the SAP Concur registration module</p> <p><b>NOTE:</b> This permission will appear only if you have enabled Meeting via the new site setup work order.</p>
Travel Meeting Center User	<p>Allows users to access meetings to which they are invited</p> <p><b>NOTE:</b> This permission will appear only if you have enabled Meeting via the new site setup work order.</p>

- **No restrictions:** Users can enter credit cards with any valid credit card number.

**Understanding BIN Restrictions**

Using the fields below you can specify sets of BIN numbers to which you'd like to restrict any credit cards entered into the system for given travel configurations.
